3 – Hazards Identification

Emergency Overview:

CAUTION! May cause eye irritation. Prolonged or repeated skin contact may cause mild irritation and defatting dermatitis. Avoid eye contact. Avoid prolonged or repeated contact with skin and clothina.

Symptoms of Overexposure:

Inhalation: High concentrations of oil mists may cause nasal and respiratory irritation. Skin Contact: Prolonged and/or repeated contact may produce mild irritation and defatting with possible dermatitis.

Eye Contact: Contact may be irritating to eyes. May cause redness and tearing.

Ingestion: This product has low oral toxicity. Swallowing may cause gastrointestinal irritation. nausea, vomiting and diarrhea. Aspiration into the lungs during swallowing or vomiting may cause chemical pneumonitis.

4 - First Aid Measures

5 – Fire Fighting Measures

Extinguishing Media: Use water fog, dry chemical, carbon dioxide or foam. Do not use water jet or flooding amounts of water. Burning product will float on the surface and spread fire. **Special Fire Fighting Procedures:** Firefighters should always wear positive pressure self-contained breathing apparatus and full protective clothing in areas where chemicals are used and stored. Cool fire-exposed containers with water.

Unusual Fire and Explosion Hazards: Slightly combustible liquid. If heated above the flashpoint, will release flammable vapors that can present a fire or explosion hazard

6 – Accidental Release Measures

Wear appropriate protective clothing (see Section 8). Eliminate all sources of ignition and ventilate area. Contain and collect liquid with an inert absorbent and place in a container for disposal. Clean spill area thoroughly. Report spills to authorities as required.

Handling: Avoid contact with eyes. Avoid prolonged contact with skin. Avoid breathing oil mists. Use with adequate ventilation. Keep away from heat, hot surfaces and open flames. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep out of the reach of children.

Storage: Store in a cool, well-ventilated area, away from incompatible materials. NFPA 30 Class IIIB Liquid.
